

# Quick Guide to Using Ebsco Eresources

## What are Ebsco Eresources?

The University subscribes to a large number of collections, sometimes referred to as 'eresources' or 'databases', supplied by the company Ebsco. These collections contain journal articles and other types of scholarly content.



## How to search across all Ebsco collections at once


If you would like to search across ALL the eresources above, follow these steps:

1. Click on any one of the Ebsco databases above and access the search screen.
2. Click on the 'Choose Databases' link at the top of the search screen, tick the databases and click OK.



## How to search using keywords

Enter your keywords in the search boxes provided. Try to think of strong descriptive words that are neither too broad nor too narrow. The strength of your keywords will determine the quality of the results that you get back. E.g.



Ebsco databases let you choose where you want your keyword to appear in the article. E.g. If you want the word 'football' to appear in the title of the article, change the 'Select a Field' option in the following way:



## How to refine your results

On the left hand panel on the results screen, Ebsco provide options to enable you to 'refine your results' to make them more specific.

The most useful options are:



Limit To

Full Text

References Available

Scholarly (Peer Reviewed) Journals

- **Full-text:** this will ensure that you can read the whole article
- **References Available:** articles that contain references are usually of a higher academic standard
- **Scholarly (Peer Reviewed) Journals:** articles that have been through the peer review process are also usually of a higher academic standard.
- **Publication Date:** use the slider to choose the range that is most appropriate for your research, e.g. last 5 years.

## How to view articles

Click on the title of the article that you are interested in from the results screen.

You will now be able to see the article's 'abstract'. The abstract is a short paragraph that succinctly describes the article. This helps you to decide whether the article is relevant for your research.

**Abstract:** The rise of celebrity **culture** is a theme that has attracted a significant amount of attention within the realm of sport and **culture** related studies in sociology. Indeed sportsmen and women were the pioneers of celebrity status in ancient Greek **society**. Associating sporting accomplishments with celebrity has now been magnified by the media and the ensuing debate on the celebrity-media nexus and the cultural changes due to globalization have acquired considerable significance in academic studies. In this essay, I endeavour to focus on Roger Milla and Didier Drogba who captured the hearts of soccer-lovers worldwide in the late twentieth and early twenty-first centuries. I will try to capture the essence of the celebrity status of these two soccer icons by evaluating their images in relation to debates surrounding African soccer, sports labour migration and the state of the domestic game. It is my argument that the two rose to iconic status because they ventured outside the continent to compete at the highest level while still maintaining and contributing heavily to the success of their national teams. The 'Tools' panel on the right of the screen gives you very useful options. Here are some of the most helpful:

- **Add to folder:** you can add articles to your folder (see the folder icon at the top of the screen).
- **Print:** print the article
- **Email:** email the article to yourself
- **Save:** save the article to your drive or to a memory device
- **Export:** this enables you to send the bibliographic citation information to a reference manager, e.g. RefWorks
- **Create Note:** you can add a personal note to the article
- **Listen:** this will provide an audio version (with downloadable mp3)
- **Translate:** a translation tool
